

**ADDENDUM No1**

**1. Schedule for receipt of the application shall be read as follows :**

1. Receipt of offers on or before 3.00 PM (1500 Hrs) on **16/10/2015**
2. Opening of offers at 3.30 PM (1530 Hrs) on **16/10/2015**

**2. Clause 15 : shall be read**

**Terms of Payment (for each Port)**

The fees shall be paid as per the following terms of payment:

**15.1 Preparation of Detailed Feasibility Report & Assistance in the bid process:**

- I. 20% on formulation of RFP document for EPC contract
- II. 15 % on recommendation of eligible bidders based on bidder's eligibility criteria
- III. 15 % on submission of technical report of the accepted offers
- IV. 15 % on submission of price bid evaluation report
- V. 15 % on submission of techno economic evaluation draft report
- VI. 20 % on submission of final techno economic evaluation report in requisite number of copies (incorporating IPA's comments, if any)

**15.2 Assist in supervision and oversight the project during installation process and final commissioning:**

- i. 20% on completion of Assisting in review of the material, data, specifications, drawings supplied by the successful bidder as per the submissions in the bid
- ii. 20% on completion of Reviewing the schedule of work against the submitted schedule
- iii. 20% Consultant would also conduct regular site visits and inspection and submit monthly report (proportionate )
- iv. 40% on Submission of completion report after commissioning of wind project

Under Clause 10, 10.1 shall be read as “**Past experience of the agency in the last 3.5 years**”
