- 4. If any adverse remark is received from the port on a resource person, his name will be deleted from the list after due examination.
- 5. Any additional information is required to be included in the CV by a resource person it will be added on the quarterly updation.
- 6. Discretion of inclusion of a resource person, solely lies with IPA.
- 7. The terms & conditions of engagement of the resource person is in accordance with Guidelines prescribed by IPA's Governing Body.
- 8. If an applicant wants to withdraw himself from the List of resource persons, he/she should inform in writing or through email.
- 9. Port will have the discretion to call any of the resource person to be engaged in any area of the CoE.
- 10. Remuneration level may be reviewed /enhanced by IPA's Governing Body depending upon the market conditions.
